Crop Failure: mother nature may serve up unfavorable weather conditions that may result in no production at all of a certain crop. Never fear we will make a substitution when necessary.

Reasonable Expectations: the growing season ahead of us is totally unpredictable. As a shareholder you are guaranteed a box of whatever produce and/or other items Burch Farms decides to share with you. Every week the volume in your box will be different. In June there are not a lot of crops harvested. By August there are numerous crops and in September some larger items may not fit in your box.

FULL SHARES

15 weeks – will receive 6-10 different farm fresh fruits and vegetables every week for 15 weeks

HALF SHARES

15 weeks – will receive 3-5 different farm fresh fruits and vegetables every week for 15 weeks

WINE ADDITION

A bottle of wine from Burch Farms Winery will be included in box every other week for 15 weeks

BAKERY ADDITION

\$10 worth of bakery items will be included in box every week for 15-weeks

Your CSA membership will save you 20% on the retail price of our fruits and vegetables. Members can expect to receive a wonderful combination of fruits & vegetables every week depending on what is at peak harvest.

Your box will be packed and ready for pickup at our Farm Market every Wednesday between 10am-6pm. There will be an option for pickup at our satellite farmers markets.
